#### TERMS AND CONDITIONS

#### A. The Responsibility and Duty of the Registered Company

### C. Scope and Limitation

#### D. Renewal of the Approval

The approval may be cancelled in cases:


- (1) Where the service provided is improperly carried out or the results are improperly reported.
