TERMS AND CONDITIONS

A. The Responsibility and Duty of the Registered Company

- (6) Where the approval fees are not paid.



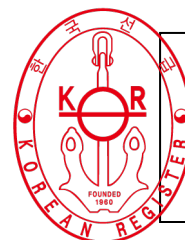
